 - Randy thinks that the letter should come from the Board...need to get more input from the full Board ...may need to be trimmed/less wordy...requested feedback by this week (2/25)...Randy will draft something for the CW also...thinks we should send a letter...
- Kara, Karen & Jeff met to discuss membership, engagement and participation...they realized that they don’t really know what’s currently happening before planning for what’s needed...so they are asking staff for a full report on what’s happening
